Camerata is committed to the Actions and Deliverable of this RAP, and we look forward to continuing to work with Reconciliation Australia and all our stakeholders in promoting Reconciliation.

STATEMENT FROM CEO OF RECONCILIATION AUSTRALIA INAUGURAL REFLECT RAP

Reconciliation Australia welcomes Camerata — Queensland's Chamber Orchestra to the Reconciliation Action Plan (RAP) program with the formal endorsement of its inaugural Reflect RAP.

Camerata joins a network of more than 2,200 corporate, government, and not-for-profit organisations that have made a formal commitment to reconciliation through the RAP program.

Since 2006, RAPs have provided a framework for organisations to leverage their structures and diverse spheres of influence to support the national reconciliation movement. The program's potential for impact is greater than ever, with close to 3 million people now working or studying in an organisation with a RAP.

The four RAP types — Reflect, Innovate, Stretch and Elevate — allow RAP partners to continuously develop and strengthen reconciliation commitments in new ways. This Reflect RAP will lay the foundations, priming the workplace for future RAPs and reconciliation initiatives.

The RAP program's strength is its framework of relationships, respect, and opportunities, allowing an organisation to strategically set its reconciliation commitments in line with its own business objectives, for the most effective outcomes.

These outcomes contribute towards the five dimensions of reconciliation: race relations; equality and equity; institutional integrity; unity; and historical acceptance.

It is critical to not only uphold all five dimensions of reconciliation, but also increase awareness of Aboriginal and Torres Strait Islander cultures, histories, knowledge, and leadership across all sectors of Australian society.

This Reflect RAP enables Camerata to deepen its understanding of its sphere of influence and the unique contribution it can make to lead progress across the five dimensions. Getting these first steps right will ensure the sustainability of future RAPs and reconciliation initiatives, and provide meaningful impact toward Australia's reconciliation journey.

Congratulations Camerata, welcome to the RAP program, and I look forward to following your reconciliation journey in the years to come.

ABOUT CAMERATA

Camerata — Queensland's Chamber Orchestra is a two-time Helpmann Award nominated ensemble and is known for innovative and adventurous programming, thriving on collaborations with artists across a range of artforms, including Grammy-award nominated artist Tenzin Choegyal, AIR award-winning and ARIA-nominated Emily Wurramara, writer and actor Tama Matheson, The New York Times' multi award-winning illustrator Peter Sis, and contemporary composer, Lembit Beecher.

Performing without a conductor, Camerata's Artistic Associates and guest artists take ownership of their music-making to form a refreshing and acclaimed voice that empowers artists, inspires audiences, and enriches communities through music.

Camerata's core business is to present concerts and musical experiences, as well as providing musical and educational services to external presenters.

We perform our mainstage concert series at the Queensland Performing Arts Centre (QPAC) as Company-in-Residence, and we are the only Brisbane-based arts organisation to also perform their mainstage series in a regional venue at Empire Theatres in Toowoomba.

Camerata performs a variety of styles of music in traditional and non-traditional spaces throughout the state and delivers schools workshops and concerts to support the education of young people. The orchestra also performs regularly in festivals, collaborations, regional tours, live-to-air national broadcasts, recording, and fundraising activities. We provide career and performance opportunities for string players who wish to build a professional, international career from Brisbane, and as a point of attraction for those returning from overseas.

OUR RECONCILIATION ACTION PLAN

We celebrate Australian music as part of our programming. We strive to celebrate the music of our time and delight in performing new works that incorporate "non-classical" items in the production. With our RAP, Camerata would like to strengthen our relationships with First Nations people of Australia with the aim of creating collaborative musical partnerships to inspire, promote and educate our audiences.

This includes embracing the opportunities within the diversity and richness of Aboriginal and Torres Strait Islander peoples' music and instruments found in traditional and contemporary forms of performance, as well as sharing our artistic collaborations with First Nations peoples' audiences.

Camerata seeks to collaborate in true and genuine partnership, not imposing colonial thinking, but to exchange our musical practices through the co-creation and collaboration of music in harmony. We see that we can be informed and inspired by First Nations thinking and approaches, even in the projects, meetings, and activities that we currently undertake.

Our team has discussed how we might strengthen our knowledge and understanding of the histories, cultures, traditions, and aspirations of Aboriginal and Torres Strait Islander peoples. We recognise that many of us were not educated about the First Peoples of this land. We were not aware of the atrocities enacted that continue a legacy of the adverse impacts of colonisation and power imbalances in many aspects of our ongoing society and culture.

Camerata's RAP is part of our intention to empower and equip us for the change we seek, to face the good and the bad of Australia's past with the hope for a future where we walk alongside Aboriginal and Torres Strait Islander peoples in unity and harmony, being mindful not to repeat history. By bringing First Nations Peoples' lived experiences and stories to the forefront as a means of truth telling and seeking the stories of others as a mechanism for healing and for change, we can enrich our creative power. For this we are committed as an organisation and as individuals to reflect on the past as a means of learning, to use our influence to be the conductors of change within our society and building for the future.

By embarking on a RAP, we commit to doing better both as an organisation and as individuals. We lead through example and provide means of learning, partnership, and reflection on a path to reconciliation. We forge a path to create social justice in Australia both as an organisation, but also as individuals

We are grateful to have previously had the opportunity to partner on occasion with First Nations Peoples for musical collaborations. However, we would like to further build and strengthen our relationships with our local traditional nations in Brisbane and surrounding areas which include, but are not limited to, peoples of the Yuggera, Jagera, Turrbal, Goenpul, Noonucal and Quandamooka nations.

We hope to establish and sustain relationships also with the respected Elders and community members within our organisation's footprint and further build our knowledge of the First Peoples of the regional areas that we visit to perform and create long-lasting relationships with them.

Camerata has commenced implementing our RAP, including:

- Support from the Board and Management Team
- Support from the Artist Associates (core member musicians)
- Engaging First Nations Elders to partner with us on our journey
- Formation of a Reconciliation Working Group (RWG).
 Membership includes two board members, Artistic
 Director, Executive Director, Marketing and Development
 Manager, two Musicians, as well as Camerata's Elder-in-Residence Aunty Nancy Bamaga
- Nominate Executive Director, Michael Sterzinger, as RAP Champion
- Nominated board member Hayley Linthwaite as inaugural RWG Chair

Acknowledging our lack of knowledge and awareness of the history of First Nations peoples of Australia, a great starting point for us is through individual and organisational learning and development. We seek to provide training and cultural immersion activities to build Camerata's knowledge and to inform our practice.

OUR RECONCILIATION JOURNEY SO FAR

Over the years, Camerata has developed rich community partnerships that have led to performance collaborations as well as a variety of internal initiatives.

In 2014, we began a friendship with Aunty Nancy Bamaga which soon after developed into a partnership. Aunty Nancy is a respected Torres Strait Islander Elder and the Founder, Managing and Creative Director of Bamaga Productions, a full-service Indigenous-owned and operated content creator, strategy, and events consultancy.

In 2021, Aunty Nancy became Elder-in-Residence to Camerata and continues to provide her wealth of knowledge and expertise to support our work with Aboriginal and Torres Strait Islander peoples. Aunty Nancy is a member of the newly formed Camerata RAP Working Group, formed in 2021.

Aunty Leslie Williams, a respected Elder in the Brisbane area for her outstanding work and accomplishments for Queensland Aboriginal communities, joined Camerata at the beginning of our reconciliation journey.

As well as her extensive work for Aboriginal communities, Aunty Leslie has also co-produced and consulted on several documentary films including *The Ration Shed* and *For Their Own Good* and co-wrote *On The Banks of the Barambah:* A History of Cherbourg. Aunty Leslie attended an informal meeting with Camerata musicians, staff, and board members in 2021 and shared some of her personal history and reflections on reconciliation.

In July 2022, Camerata engaged consultant Olivene Yasso, a Yiman woman of the Central-west Queensland nation and an Australian born South Sea Islander, to guide us on our RAP. Olivene brings her wealth of knowledge and expertise to support the development of our RAP.

Camerata also recently worked with respected Elder Aunty Flo Watson and Renai Mouton to assist us in facilitating a cultural awareness session with our musicians, staff, and board members. This truth-telling session was a confronting but important learning session for our organisation and deepened our commitment to our RAP journey.

Artistically, Camerata has partnered with First Nations artists including Dr G, William Barton, and Emily Wurramara.

In 2015, we were delighted to have the beautiful opportunity to perform with Dr G at the Darwin Festival — a major highlight of our collaborations.

William Barton is widely recognised as one of Australia's leading didgeridoo players and composers. Several performances together over the years led to a guest appearance at Camerata's mainstage performance, *From My Homeland* (2023), with captivating violinist Vèronique Serret.

Emily Wurramara is a First Nations Australian Indi-pop and roots artist, singing both in English and Anindilyakwa (the traditional language of her home Groote Eylandt, Northern Territory). After a chance encounter performing with Brendan Joyce in a program at Ukaria in Adelaide, we invited Emily Wurramara to feature as a special guest performer in a mainstage concert in 2021.

Through this connection and partnership, we then collaborated on a full-scale performance with Emily at the Brisbane Powerhouse in October 2022.

We look forward to future collaborations across creative industries to explore new creative possibilities while acknowledging, honouring and paying our respects to the First Peoples of Australia.
